Excellent Year 12 Results

On behalf of the College community, we congratulate the Year 12 Class of 2022 on their excellent South Australian Certificate of Education (SACE) results.

We again had **100% South Australian Certificate of Education (SACE) completion rate**, as has been the case for many years at Mount Carmel College. **More than 99.4% of all grades awarded were C- or higher and there were no E grades at all.**

Special congratulations to our **Dux of 2022, Jessica Ho**, who achieved an adjusted ATAR of 96.60.

91% of our students who applied for university received an offer in the first round and of these, **75% were offered their first preference.**

We are very proud of the outstanding results achieved by

our Year 12 students. We know that excellent academic achievements are the result of a lot of hard work and the wonderful partnership in learning between the student, parents, teachers, support staff and the College. Our Year 12 students enthusiastically participated in the many different opportunities open to them through Mount Carmel College.

It has been exciting to welcome so many new students and also those who have returned to us in 2023. As always, we have begun the year with a flurry of activity – Year 9 Camp, Parent Information Sessions, Year 7 Reflection Day and our Opening College Mass. All of these things help us to make connections to the core values and traditions of the College and hence identify with our motto ‘Love and Dignity’.

One of the things that we are reminded of at the beginning of each year is uniform.

Mount Carmel College has a detailed Uniform and Procedures document. These uniform requirements are a compulsory requirement of being part of the school community. The following extract comes straight from our policy document and reminds us of the purpose of our uniform requirements:

At Mount Carmel College, students wear a compulsory student uniform with a sense of pride in belonging to the school community. The student uniform promotes equity and equality, self-discipline and care. While at school and in the community, students represent the legacy, tradition, and values of the College by proudly wearing

the student uniform with the motto Caritas et Dignitas (Love and Dignity), reflecting the high standard of behaviour required of a Mount Carmel College student.

Health and safety factors are important when incorporating items of clothing as part of the student uniform. Specific instructions for wearing the uniform may apply when undertaking certain tasks or in particular locations.

NAPLAN

On Tuesday, 28 February our Year 3, 5, 7 and 9 students will be participating in the National School Practice Test in preparation for undertaking the online NAPLAN tests in March. The School Practice Test will not involve any scoring, marking or reporting of student performance. Participating in the trial is important because it will help us to confirm our technical readiness for NAPLAN online. During the trial we will also have practice managing the classroom procedures for online assessment as well as the test administration process.

Inclusion

As a school we have what the law defines as a duty of care towards the students enrolled. While the courts recognise that accidents cannot be totally prevented, schools are charged with the responsibility of ensuring the type of supervision which a normal parent would provide, considering the age of the student and the activity in which she is engaged. I would like to remind parents and students about several points which arise from the school's duty of care:

1. Students will be supervised within the school grounds each school day from 8:05am on the secondary campus and 8:30 am on the primary campus.
2. Students are supervised at recess and lunch times.
3. When dismissed in the afternoon, students are expected to leave the school grounds immediately and proceed directly home.

Students staying for activities organised by the school, such as sport or drama practice, will be supervised.

4. If a student is late or absent it is the responsibility of Parents/ Guardians to notify the College before 9:00 am. To do this, a text message can be sent to 0438 368 846 and include student name, Pastoral Care Group/Primary Teacher, reason for lateness/ absence and the date. This number is only available for text messaging. If the College has not been notified of an absence or late arrival by 9:00 am, an SMS text message will be sent to Parents/Guardians that morning, advising them that the student is not at school. It is the responsibility of a Parent/Guardian to provide current and updated mobile numbers to the

These measures ensure that both parents and staff are able to exercise their legal responsibilities for the students in a way that ensures a responsible degree of safety.

NAPLAN ONLINE SCHOOL PRACTICE TEST / NAPLAN ONLINE 2023



National Assessment Program – Literacy and Numeracy (NAPLAN) assess literacy and numeracy skills that are essential for every child to progress through school. Students in Years 3, 5, 7 and 9 participate in the annual NAPLAN tests in reading, writing, conventions of language (spelling, grammar and punctuation) and numeracy.

Schools have transitioned from paper-based to computer-based assessments. All Year 3 students will continue to complete the writing assessment on paper. NAPLAN Online is a tailored test that adapts to student responses, presenting students with questions that may be difficult – resulting in better assessment and more precise results.

On Tuesday 28th February, our Year 3, 5, 7 and 9 students will be

participating in the national School Practice Test in preparation for undertaking NAPLAN tests online in March. The School Practice Test will not involve any marking, scoring or reporting of students' performance. Participating in the trial is important as it will help us to confirm our technical readiness for NAPLAN Online. During the trial, we also have the opportunity to practice managing the classroom procedures, as well as the test administration process.

New in 2023, NAPLAN Testing will be conducted in Term One. The NAPLAN test window is from Wednesday 15 - Monday 27 March, not the May date in previous years. This means results will be available to education authorities earlier in the year to inform school and system teaching and learning programs.

Apart from the school readiness test, all schools, students and teachers can familiarise themselves with NAPLAN Online and the types of questions to be included, by using the public demonstration site available at <https://www.nap.edu.au/online-assessments/public-demonstration-site>

NAPLAN tests are one aspect of each school's assessment and reporting process. It is a snapshot of learning at a particular time and is not the only form of assessment we gather to understand where our learners are in their learning cycle.

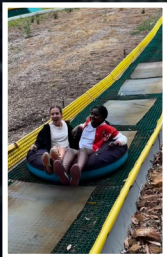
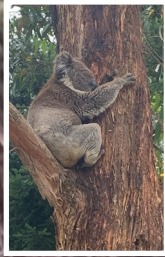

SCHOOL FEE STATEMENTS

Thank you to all those families who have contacted me to arrange payment plans, School Card Applications and Catholic Primary Sibling Discount forms, it is appreciated.

Statements will be issued within 2 weeks and I thank you for your patience and understanding whilst I work towards finalizing them. When you receive your statement, please check that all information is correct and please refer to our 2023 Fee Schedule on our website for further detailed information which may have relevance to your family. Any anomalies noticed on your statement, please contact me as soon as possible so it can be addressed. Our checks try to minimize this occurring but as you can appreciate, we may have overlooked something and seek your assistance.

PAYMENT PLANS

It is your responsibility to arrange a payment plan that ensures you meet the scope of our School Fees Policy by your account being paid in full by 30 November each year. This involves reviewing your payment plan regularly. I am available to assist you with this process at any time so please do not hesitate to contact me. If you have any concerns meeting that date, please contact me as soon as you possibly can as it is important to us that we apply an appropriate plan and support to individuals who are experiencing any challenges. Please

be assured that all discussions remain confidential.

New Payment plans need to be completed and lodged to me annually unless it has no end date. They are not automatically renewed.

If you have a payment plan with no end date you need to review your plan annually and complete & lodge to me an amendment payment plan if required, to ensure your account is paid in full as per our Fees Policy, by 30 November.

SCHOOL CARD

To receive Tier 2 Fees (unless approved otherwise) annually at the beginning of each year you will need to complete a School Card Application. They are available online (our preference) or you can lodge with me a hard-copy as soon as possible. Anyone who was eligible last year or new families commencing this year who provided me with a copy of their Centrelink card along with a \$50.00 Acceptance of Offer payment will automatically have Tier 2 fees applied.

School Card discounts will be reversed if we are notified that you are not eligible, and no further action is taken on your part which will confirm with us that you agree with their assessment of your application. If you do not agree with their assessment, then please either complete a Reassessment Form providing them or me with supporting documentation to lodge or contact me to discuss further.

Human papillomavirus (HPV) vaccine

Changes under the National Immunisation Program
in 2023



From the 6th of February 2023, the Human Papilloma Virus (HPV) vaccine will change from the routine two doses to a single dose.

The change is based on advice from the Australian Technical Advisory Group on Immunisations (ATAGI) who have considered the latest and international scientific and clinical evidence which has concluded that a single dose of HPV vaccine delivers comparable protection to two doses.

If consented for, students in Years 7 and 8 will receive a single dose of the HPV vaccine and a booster dose of diphtheria Tetanus and pertussis (whooping cough) This will be the last year for year 8 students to receive these vaccinations at school, from 2024 they will be offered to all year 7 students bringing South Australia in line with the other states in Australia.

Students in Year 7 are scheduled for their immunisations on **Thursday 30th November 2023**

Students in Year 8 are scheduled for their immunisations on **Wednesday 24th May 2023**

Collection Notice for parents/guardians

2023 Student Residential Address and Other Information

The Australian Government Department of Education (the department) would like to notify you that we have requested for your child's school to provide residential address and other information.

Under the *Australian Education Regulation 2013*, the school is required to provide the department with the following information about each student at the school:

- Names and residential addresses of student's parent(s) and/or guardian(s)
- Student residential address (**excluding student names**)
- Whether the student is a primary or secondary student (education level)
- Whether the student is boarding or a day student (boarding status).

The school collects the above information by generating a **unique and unidentifiable** – student reference number (SRN) for each student record. The school only uses the SRN for this collection. **It is not allowed to be used for any other purpose.** The number only indicates to the department that each record provided is for one student.

Purpose of the collection

The Student Residential Address and Other Information Collection (the Collection) informs Australian Government school education policy and helps ensure funding for non-government schools is based on need.

The information collected will be used to inform school funding calculations. It is combined with Australian Bureau of Statistics (ABS) data to calculate a non-government school community's capacity to contribute to schooling costs.

From 2020, the department introduced a new measure of capacity to contribute: the Direct Measure of Income (DMI). The DMI is based on the median income of non-government school students' parents or guardians using the Collection data. Use and disclosure of personal information

Your personal information is protected by law under the *Privacy Act 1988* (Cth) (Privacy Act). Personal information is information or an opinion about an identifiable individual. Personal information includes an individual's name and contact details.

Any use or disclosure of your personal information must occur in accordance with Privacy Act and the *Australian Education Act 2013* and *Australian Education Regulation 2013*.

Your personal information provided to the department through the Collection may be:

- disclosed to a contracted auditor where the department may from time to time, carry out an audit of a school's collection submission. The contracted auditor compares the school's submission with the school's student enrolment information. The contracted auditor will not use the information for any other purpose.
